## WE ARE THE DIOCESE

In his Charge, which was delivered in two parts at Synod, and was introduced by way of a video message to the diocese in early September, the bishop highlighted three priorities for the next biennium:

1. Implementing Transforming Futures fundraising initiative to raise \$7m over seven years
2. Putting the Gospel at the centre of all that we do.

3. Lay Ministry & Leadership Development through a "Season of Discipleship" and a commitment by all Anglicans to practice a "Rule of Life"

The bishop reminded members of Synod that, "over the last number of years, we have shown a fortitude and faithfulness that will prove those who doubt us wrong."

In Part II of his Charge, Bishop Logan encouraged the diocese to think ahead:

“The story we choose to live today is the story of tomorrow. In the future, when Anglicans gather on these islands and inlets and ask how we contributed to the world in which we lived, it is my hope that they will see us as story-telling and story-living people. That we took the story of Jesus Christ and lived it in our day; that we took the story of Jesus Christ

and, despite our differences, together we were able to move with confidence and with God, to transform our future. Let it be said of us that we had hope and faith. Let it be said of us that with humility and dignity formed by this faith and through this synod we adjourned the courts of despair and shone light in the dark corridors of pessimism. Let it be said of us that we were prophets of a future not of our own.”

## RECONCILIATION & BEYOND

The diocese’s commitment to this vision direction (Reconciliation and Beyond) was acknowledged in numerous ways throughout Synod including: the location, the meaningful participation of First Nations in opening worship and a Sunday afternoon panel discussion moderated by Martin Brokenleg, as well as a reflection on the past two years as we have been led by the Sacred Journey the bishop first began in 2016.

Speakers spoke passionately about moments when they have seen reconciliation in action and those times when they have experienced the opposite. For example, Kevin Arndt told about the personal impact of working as a chaplain in the prison system with the now-grown children of residential school survivors whose harrowing stories he first heard in the Truth and Reconciliation Commission hearings.

**SYNOD GOAL:** Demonstrate a strong, clear sense that after the diocesan year of reconciliation we are beginning to establish new relationships, built on trust and mutual respect, with the First Peoples of these islands and inlets.

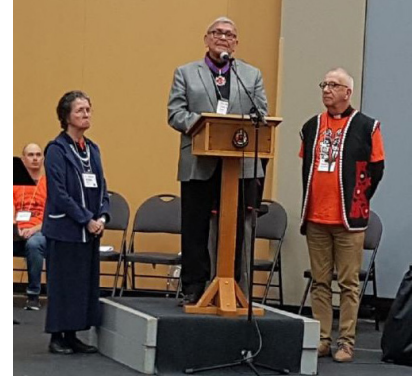
## Doreen Davidson

# TRANSFORMING FUTURES

**SYNOD GOAL:** Delegates understand and approve a realistic five-year financial plan that includes a substantial fundraising component.

Divided into three parts, the Transforming Futures presentation included presentations from the parishes of Trinity, Port Alberni and St Michael & All Angels, Chemainus as well as by Ansley Tucker, dean of Columbia and incumbent at Christ Church Cathedral.

In the two parish presentations, the incumbents, along with other representatives shared how they will participate in the initiative at a local level, including fundraising goal, timeline and how the project will help their parish live out the diocesan vision as represented in their context.

In the third presentation Ansley Tucker explained how Transforming Futures will work at both the parish and diocesan levels, and provided opportunity for delegates to ask questions and provide input prior to the vote.

On Sunday morning, Synod unanimously passed a motion to launch Transforming Futures and to encourage all parishes to participate. The first parishes will launch their initiatives as early as January.

Michael Wimmer (incumbent, St Michael & All Angels, Chemainus) will act as facilitator to help launch the program diocesan-wide.

## LIVING OUR VISION

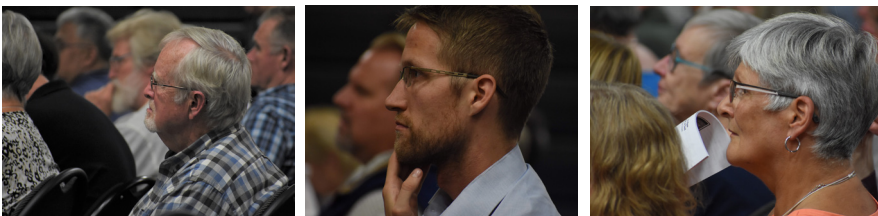
This three-part presentation facilitated by Ian Alexander and Brendon Neilson reported on accomplishments since the last Synod in the vision area of focus: Faith in Action, Faith in Formation, Faith in Foundation

Numerous presenters shared stories of vision-related projects that have been initiated at the local level, with the encouragement and support of the diocesan Vision Fund.
